The Asian Journal of Legal Studies (AJLS) is the flagship journal of the Asian Law Students' Association. It publishes articles relating to the study of the legal system of Asian countries, and features comparative legal analyses and broader issues on legal reform in individual countries. The Journal fulfills the need for increased communication and enhancement of the understanding of legal studies among Asian countries by serving as a platform for contributors to express their views on Asian legal affairs. Through its wide dissemination of articles, the Journal hopes to serve a broader Asian community. The Journal's contributors and audience include students, academics, professionals, and others interested in the field of Asian legal studies.

A. General Information

1. The AJLS submission is open for ALSA members and non-members.
2. The AJLS can be submitted by **individually, pairing** or a **maximum number of four people** per article.
3. The theme of AJLS is in accordance with the academic theme of ALSA International Board 2021/2022 which is **“Human Rights Dimensions of the COVID-19 Pandemic”**.

4. The authors must first send in an outline of the full article which will go through a selection process by the external reviewer. The outline article may or may not be accepted for full article submission and publication.
5. Authors whose academic writing is managed to be published in this term's AJLS will receive an *e-certificate* as a token of appreciation.
6. The submission of AJLS will consist of :
 - a. Outline Submission;
 - b. Initial Review;
 - c. Full Article Submission; and
 - d. Editing Process.
7. The article will be reviewed by a professional.
8. The editing process of AJLS will be done by the Executive Editors of ALSA International 2021/2022 under the supervision of the Department of Academic Activities ALSA International 2021/2022.
9. The review and editing process of the article may include revisions which require active communication between the editor and authors of the article.

B. Requirements for Outline Submission

1. The outline for the article should follow the format of :
 - a. Abstract;**
 - b. Background;**
 - c. Analysis; and**
 - d. Conclusion.**

The article may be explained using the Issues, Regulation, Analysis, and Conclusion format.

2. The outline for the article must **not exceed more than two pages**.
3. **The outline must be written in (.docx) format with the writing requirements as stated in the general requirements of ALSA International Academic**
